Santa Cruz County Immigration Project (SCCIP)

If you are in need of food on the north coast of Santa Cruz County, visit one of CAB's [Davenport Resource Service Center's \(DRSC\)](#) food distributions:

- Regular food distributions the first 3 Tuesdays of the month from 2-4pm at DRSC: 150 Church St. Davenport, CA 95017.
- The second and third Tuesdays of the month, beginning again in April, DRSC delivers food to the farms on the North Coast.
- For seniors over 55 enrolled in Grey Bears' Healthy Food Brown Bag Program, DRSC will continue to deliver food bags directly to your home, Thursdays between 12pm and 1pm until further notice.
- For families with children at Pacific Elementary and youth 18 and under on the north coast of Santa Cruz County, you can pick up free food bags at DRSC from 11am - 1pm Monday - Friday.
